

Disabilities targeted: Visual impairment/Albinism. **Location of activities:** Regional (Africa) and National (Kenya). **Organizational background:** The African Braille Centre (ABC) is a regional Non Governmental Organization based in Nairobi, Kenya. In operation since 1987, ABC has contributed significantly and in several ways to the development and access to education for learners with visual impairment in Kenya and the region for the last 22 years.

Vision: A society in which people with visual impairment have access to educational, professional and general interest materials as well as devices and services suited to their needs.

Mission: To promote and enhance the educational, professional and general provision of materials; devices and related services appropriate to their needs in order to enable them become active and effective participants in society.

Activities: ABC is committed to advancing the cause of people with disabilities in Kenya and the region through awareness creation, lobbying and advocacy, networking, partnership and collaboration, as well as building the capacity of those who work with and for them. Supporting partners to deliver value to their beneficiaries, their benefactors and supporters is an integral part of ABC's strategy. ABC takes special pride in providing quality and affordable services to partners in the disability, education and development sectors as part of her strategy of addressing the needs of these sectors.

Service Delivery

Braille Transcription / Provision of Teaching and Learning Materials ABC is premier institution in the country and the East and Central Africa Region producing teaching and learning materials for learners with visual impairment. In Kenya, ABC seeks to ensure that all schools offering education to the visually impaired through special schools and integrated education programs in the country have equal access to key curriculum educational materials at par with their sighted peers.

ABC produces Braille materials and distributes them primarily to educational institutions and other users such as: Government Departments, local and international NGOs and individuals with visual impairment. ABC currently supports 19 Integrated Education Programmes spanning 35 districts in Kenya. It also supports 6 Special Primary schools and 1 Special Secondary School for the Blind in the country. ABC supports learners within integrated educational programmes, Special Schools for the Blind and teacher training colleges spread across the country.

Digital Audio Transcription & Media Services

In pursuit of her mission of providing services within these sectors, ABC runs a state-of-the-art audio recording and transcription studio and media services at their offices in Nairobi West. These services include:

- Full production of digital audio books, research and annual reports, conferences proceedings;
- Conversion of regular printed text materials (magazine, journals, reports, etc) or electronic text into digital audio format;
- Live recordings and transcription of focus group discussions (FGD);
- · Hiring out of studio services for your own customised production;
- Live coverage of music, drama, field events, programme events;
- Production of broadcast quality radio programmes;
- Documentary voice-over recordings for television;
- Awareness creation and advocacy materials;
- Recorded interviews, research support;
- Complete documentaries for radio;
- Audio advertising materials; etc.
- Perkins Brailler Services

In pursuit of her mission of providing services within these sectors, ABC operates a full Perkins Brailler Workshop and Spare Parts Depot at their Nairobi West offices. These services include:

Distribution of Perkins Braillers to your partners in Kenya and in the region;
Procurement of new Perkins Braillers (both single units or in bulk);

- Full range of Perkins Brailler spare parts;
- Perkins Brailler repair kits;
- •Brailler dust covers;
- •Scheduled maintenance service (at the workshop or on client's site);
- •Needs Assessment for Braille services and Braillers;
- Consultancy services on any aspect of Braillers;
- •Assistive devices for use by people with visual impairment;

•White canes, slates and stylus, Abacus, Talking calculators, Braille watches, and other accessories;

•Sports and games accessories like goal balls; board games for the visually impaired, etc.

• All other accessories and devices (including digital audio talking books) for the visually impaired may also be procured on order.

Capacity Building

ABC regularly transfers skills and knowledge that either directly or indirectly enhances the quality of life of persons with visual impairment. ABC supports and organizes training of key educational personnel who support learners with visual impairment within educational institutions.

Training and Consultancy

ABC offers training and consultancy services in Braille; production planning and control; management of Braille production facilities; technical training in Braille production; repair and maintenance of production equipment; as well as in making of tactile maps and diagrams both for clients in Kenya and the region.

Advocacy and Awareness Creation

ABC always supports the initiatives of other local and international organizations and stakeholders with interest in expanding access to education and services to persons with visual impairment through creating awareness on the capabilities of persons with visual impairment or reduction of the burden of visual impairment. ABC is an active supporter; organizer and participant at national and international events and activities that seek to create greater awareness on the capabilities of persons with visual impairment.

ABC has collaborated with other stakeholders to lobby for the development and adoption of appropriate legislation and policies that will ensure the inclusion of persons with visual impairment, as well as enhance their educational achievement and quality of life. ABC is also at the forefront of advocating and lobbying for increased employment opportunities for persons with visual impairment.

Networking, Partnership & Collaboration

ABC pursues active collaboration with other public and welfare organizations as an active partner working towards the general welfare of persons with visual impairment. ABC also has active collaboration with institutions in Ethiopia, Uganda, Tanzania and Mozambique as well as several West African countries. ABC will continue pursing partnerships with other institutions and organizations with a similar mission as hers. Through this collaboration, ABC contributes to enhanced advocacy and information sharing on good practice for people with disabilities in general, and those with visual impairment in particular.

Technology

ABC recognizes the challenges posed to people with visual impairment by the fast-changing technological environment. To address this challenge, ABC pursues collaboration with other partners to promote access to and use of assistive technology for VIPs, while appreciating and addressing the limitations this may cause to them where appropriate interventions are lacking. ABC also keenly keeps abreast of new developments in Braille transcription and production technology and invests appropriately in order to harness its wealth of knowledge in the sector for the benefit of her key stakeholders. ABC also ensures that it takes full advantage of the latest and up-to-date technology that allows her to provide the best services to her beneficiaries, clients and other stakeholders.

Research

In order to keep abreast with new developments in Braille and audio transcription and production technology as well as assistive technology and access devices for people with disabilities, ABC is involved in research and invests appropriately to enhance this area for the benefit of its beneficiaries and other stakeholders in the sector. ABC is also involved in research around poverty, HIV/AIDS, policies, education and other social issues that affect people with disabilities.

Location of activities: Makueni district ie Kibwezi, Wote, Makindu and Mtito Andei districts.

Activities

Disability prevention

In partnership with other organizations, AMREF is involved in prevention and health care, through the Flying Doctors Service which works closely with the Kikuyu Eye Clinic and the Kijabe Hospital within outreach programmes. Mobile clinics help in the prevention of cerebral malaria and with access to sanitation against disability.

In the field, AMREF has operated for twelve years in Kibwezi, Makueni and Mtito Andei districts. They operate home and safety programmes acts to minimize the factors of disability. To remove the stigma and demystify disability, an awareness programme has been setup including a child to child project. AMREF also provides appliances for persons with physical disabilities.

Capacity Building

AMREF programmes also consist of technological transfer through training programmes in physiotherapy and occupational therapy seconded by the Ministry of Health.

Some community health workers also provide training to parents and act to enable the community to have the technological skills to face disability.

Socio-economic empowerment

Education Programme: AMREF gives little bursaries to children with disabilities in secondary schools.

Training Programme: Vocational training is provided to persons with disabilities.

Field of work: Rehabilitation of people with physical disabilities, cerebral palsy and multi-handicapped children.

Location of activities: Nairobi, Coast, Kisumu, Kisii, Nakuru, Machakos, Busia and Embu.

Activities

Rehabilitation Clinics

All the branches provide rehabilitation clinic services (orthopaedic surgery, shunting, occupational therapy, physiotherapy) with the intervention of physiotherapists, occupational therapists and orthopaedic technologists.

CBR programmes

The Nairobi branch runs a Community Based Rehabilitation Programme in Mukuru village in Industrial Area and a day care centre was recently set up at Lunga Lunga Village. The CBR programme at the Coast branch also covers slum areas. A new rehabilitation centre has just been opened within the Bombolulu Project.

Mobility AIDS Workshop

The Nairobi, Coast, Nakuru, Kisumu and Embu branches run orthopaedic workshops. These workshops build appliances for people with disabilities and employ them to produce wheelchairs, tricycles and crutches. In Nairobi, the orthopaedic workshop is the main income generating section of the Branch. The orthopaedic workshop has moved to Kabete.

Mobile Outreach Teams

Rehabilitation Services covering Machakos and Kitui districts are provided by the Nairobi Branch in addition to services in Kariobangi, Korogocho, Ngong and Mukuru areas within Nairobi. A home visit programme also deals with physical rehabilitation for surgical cases. In Kisumu, the mobile clinic reaches an average of 200 patients per year.

Nairobi Province

Other activities

- The Masaku School for the Physically Handicapped is supported by APDK Machakos Branch to improve the standard of education and the physical facilities.
- The Likoni Furniture workshop at the Coast makes up an income generating programme for persons with physical disabilities.
- The micro-finance Programme of FAIDA (Coast branch) consists of loaning amounts to people with disability who want to start income generating activities.

Challenges

- To extend the day care centre programme into other areas of Mukuru
- The use of the orthopaedic workshop of Kabete in order to increase the production of appliances and benefit from economies of scale.
- An orthopaedic workshop in Kisii Branch is about to be created.

Our mission is to maximize the full potential of the Deaf blind person and the family around him/her through sustainable relevant hands on and practical training that serves their needs and aspirations and bettering their livelihoods.

Disabilities targeted: We work all over Kenya for deaf blind young adults and their families.

Organizational Background: Brian Resource Centre is an young NGO created around one Brian who is Deaf blind. It was established in 2006 as a Community Based Organization to empower Deaf blind persons and their families through hands on training in various practical economic and livelihood skills. It has since transformed itself into a Kenyan NGO. It officially commenced operations in 2007 with seven students. 12 young adults and their families have since passed through the centre.

The Deaf blind forms a minority group within the wider disability sector. We believe that through our initiative, we can make significant contributions to address the unique challenges and issues facing the Deaf blind and the families within which they grow and live. Our trainees are sourced from all corners of our country. The knowledge and skills learned go far and wide. We also train members of our community on what we do. Our Centre is therefore a focal point for community transformation.

Activities implemented by the organization

1. We offer training in the following areas

- Sustainable entrepreneural skills targeting the trainees and their families
- Modern sustainable crop and animal husbandry skills and practices
- Sustainable environmental management and conservation skills
- Knitting and weaving
- Value addition and marketing skills
- Daily living Skills and life skills
- · Rudiments of information and communication technology

2. We place emphasis on utilizing and managing locally available resources and inputs at family and community levels, doing simple and ordinary activities in an extraordinary way.

3. Reaching out to persons who are Deaf blind, their families and the community with information, knowledge and skills on reproductive health, HIV and AIDS, gender equity and nutrition.

4. Building strong spiritual norms in persons who are Deaf blind and their families by exposing them to the routine of worship.

5. Reducing stigma, isolation, discrimination and general negative attitude of the community that Persons with Disabilities are a burden and unproductive in the community.

6. Supporting and linking up with initiatives aimed at advocating and lobbying for the rights of persons who are Deaf blind and their families on issues related to all aspects of their lives.

7. Information gathering, analysis and dissemination and sharing

8. Encouraging and supporting sporting and cultural exchange activities.

We also address the following cross cutting issues:

Poverty: Alleviating poverty not only in Deaf blind persons, but also in their families and the community as a whole. This is from the belief that disability is both a cause and a consequence of poverty.

Participation: Active participation of all the stakeholders at all levels such as at training needs assessment, planning and implementation of the training programme, identification of the project to be undertaken at home, planning, implementation, monitoring and evaluation.

Gender: Gender balance in the selection of trainees as well as support staff placement and deployment. All the family members are offered an equal opportunity.

Rights Based and Social Model of Disability: We believe that disability cannot be taken away medically, and so address economic and social empowerment as basic human rights and not charity. Service provision must be based on Rights Based Approach as opposed to charity. We strive to change attitudes, remove both attitudinal as well as environmental barriers and eventually eradicate stigma. Deaf blind persons can gain inclusion in society.

Sexual and Reproductive Health as well as HIV and AIDS: We have a component to make sure that our trainees and members of their families have access to both reproductive health and HIV and AIDS services. This is due to their vulnerability to all their negative effects and challenges.

Environment: We address environmental conservation from controlled and reduced storm water, to recycling garbage and adding value to it to become fertilizers, turning charcoal dust and waste paper into useful and totally combustionable products, keeping the environment green by plant cover, especially fodder, food crops and trees.

Health: The foods we raise are in themselves very nutritious. The presence of traditional vegetables is an added plus. We all feed on these with very encouraging results.

Focus on Youth: For a youthful society such as ours, we think we can revolutionalize agriculture by interesting the youth to participate in more farming activities.

Vulnerability: We address vulnerability by unmasking it. We are dealing with a disability segment that is already marginalized within the wider disability circles. Poverty is only secondary to it.

Field of work: The mandate of CBM is to bring help to people in need in the developing countries of the world, specifically those who are blind or otherwise handicapped. CBM concentrates on medical eye care services and prevention of blindness as well as education and rehabilitation programmes. Fields of service include medical eye care, treatment and rehabilitation of the physically disabled, education and rehabilitation of the deaf, blind and deafblind, and vocational training. CBM is also extensively involved in training of ophthalmologists and other eye care personnel for African programmes.

Location of activities: Majority of CBM supported projects are located throughout Africa and Asia. Others are located in Latin America, Mexico and the Caribbean. The Regional Office for East Africa is in Nairobi. Activities are geographically distributed throughout the three East African countries.

Status: International NGO and registered non-profit charity based in Germany, founded in 1908 and established in Kenya in 1967.

Activities

Medical Eye Care

CBM is currently supporting 35 eye care partners in the three East African countries in surgical treatment and prevention of blindness activities. These hospitals, located in both urban and rural areas, receive CBM support in the form of medical supplies, equipment, instruments, expertise and other operational costs. In Kenya, these units include PCEA Kikuyu Eye Unit and Low Vision Project, Sabatia Eye Hospital in Western Kenya, Lighthouse for Christ and Kwale District Eye Centre both in the Coast Province and Tenwek Hospital Eye Unit in Bomet among others.

CBM also supports outreach programmes by the eye care partners to outlying areas where eye care services are not accessible or available. These can be either mobile outreach by road and air within the country or cross border safaris from Kenya into Somalia. Outreach into Somalia is conducted via PCEA Kikuyu Eye Unit. Remote and other hardship areas such as North-Eastern Kenya and Tana River District are also covered via CBM support.

Training of Eye Care Personnel

CBM is actively involved in the training of ophthalmologists at the University of Nairobi, Department of Ophthalmology. The organization fully or partially supports costs of the four (4) year Master of Medicine training in Ophthalmology for selected candidates through the CBM Sponsorship Programme.

Additionally, CBM supports reputed partners such as PCEA Kikuyu Eye Unit to provide training for lower cadre ophthalmic personnel such as Ophthalmic Assistants, low vision therapists, ophthalmic theatre nurses.

Education for the deaf, blind and deafblind

CBM is currently supporting education of the deaf, blind and deafblind together with their partners. Within this training, the importance of daily living skills and vocational training is emphasized to enable the recipients to enjoy a higher degree of independence, better integration into their communities and some form of income generating skills.

Community Based Rehabilitation Programmes

CBM supports several Community Based Rehabilitation Programmes in the region. The CBR Programmes function to identify cases of disability for attention at referral centres and provide the necessary post operative followup.

Treatment and Rehabilitation of the Physically Disabled

Surgical correction and rehabilitation of physical disabilities is part of the core of CBM's work in East Africa. Orthopaedic units and hospitals such as PCEA Kikuyu Orthopaedic Unit in Kenya and CCBRT Disability Hospital in Dar Es Salaam provide the necessary treatment, while rehabilitation is also provided through these orthopaedic and CBR centres.

Activities: Eye Care: CESO works with partners in facilitating access to eye care services. In partnership with Mbagathi District Hospital, CESO facilitates access to eye care services through the hospital's Static Eye Clinic, as well as through outreach program to the communities in Kibera and Dagoretti, and other divisions in Nairobi. The main focus of these services is preventive and curative services to eye patients with eye ailments and those in need of overall eye care services. Activities include testing for visual acuity, carrying out examinations and diagnosis; as well as corrective eye surgery where necessary.

Education: CESO works in partnership with the Nairobi City Education Department as well as the Provincial Director of Education. Through these partners, CESO is able to support education services for children with visual impairment within Nairobi under the auspices of the Nairobi Integrated Education Programme (NIEP) for the visually impaired. NIEP is a programme of the Ministry of Education under the Kenya Integrated Education Programme (KIEP) for the visually impaired.

Community Based Rehabilitation: CESO works with partners and also directly with persons with visual impairment within Kibera and Dagoretti divisions of Nairobi. Under this programme, CESO seeks to empower people with visual impairment within the programme areas to attain independence. The support from CESO also seeks to ensure that persons with visual impairment in the programme areas reach social functional levels by facilitating their acquisition of appropriate skills aimed at changing their lives towards full social integration.

KSDC provides hearing aids in partnership with VSO, distributes drugs and carries out the identification process. The prevention of deafness (infection) is undertaken with the ICCO prevention of deafness programme (Holland) through visits into villages.

Advocacy

KSDC lobbies for the institutionalization of sign language. A Review Commission encourages children's network between Child Welfare Society, UDPK and KNAD.

KSDC was also involved in the campaign for the Disability Act.

KIEP supports the inclusion of blind children into the main stream education system. The support includes building the capacity of teachers through training to handle visually impaired children, provision of special learning equipment and materials such as Braille machines, white canes, low vision devices, and creating awareness within the communities on the rights of visually impaired children to access quality education.

Eye Care

KSB's eye care programme includes producing and distributing basic affordable eye drops, supporting primary eye care, procuring and distributing ophthalmic equipment and consumables and supporting the development of eye care workers. Annually, KSB produces over 100,000 bottles of low cost quality eye drops to supply government and mission hospitals and is in the process of modernizing the current production unit due to increased demand. In conjunction with its partners, KSB coordinates free medical camps offering eye screening and treatment for eye diseases in rural areas throughout the year. On site, an eye clinic and optical shop offering affordable eye screening and prescription reading glasses is available to the general public.

Rehabilitation

KSB has provided rehabilitation services for the blind through institutions such as Kinunga Agricultural Training Centre for the Blind, Machakos Training Institute for the Blind, Siakago Bakery and the Centre for Adaptive Technology (CAT) in Nairobi where visually impaired persons are given computer training. This department is also involved in advocating for the rights of persons with visual impairment through lobbying and collaborating with other visually impaired organisations.

Community Based Rehabilitation/ Comprehensive Eye Services

The Community based rehabilitation/ Comprehensive Eye Services (CES) projects in Kericho, Bomet, Bureti consists of local rehabilitation projects linked with the community and integrating all sectors of comprehensive eye services: health care, rehabilitation and education. CES is supported by public awareness through advocacy on preventive measures of blindness. This project is a partnership between Kenya Society of the Blind, Sight Savers International, African Braille Centre and the Ministry of Education. • We have established post-test clubs to support our clients who have already undertaken VCT services to discuss and exchange HIV/AIDS information.

Challenges

Majority (90%) of deaf face major challenges to provision of VCT services due to the nature of Deaf population distribution, distance and poverty.
Most of deaf clients in rural areas have very low knowledge on HIV/AIDS. Much time is hence spent on explaining issues and giving facts.

• Disruptive deaf politics has been a big challenge. However we believe, through the national forum, positive engagement can be harnessed for the benefit of the clients and site. Their optimism has informed us to see the opportunities in those challenges as such they can contribute to better the situation despite it sometimes interrupting our services delivery to the Deaf community.



The coordinating office within Kilimani Primary School is in charge of identifying the children with visual impairment within schools (primary, secondary, college) and community (home based programme) so as to incorporate them into the special unit.

The Nairobi Integrated Education Programme consists of a network of schools which collaborates to identify children with visual impairment. 14 itinerant special teachers help kindergarten to identify the children with visual impairment. So far 190 visually impaired children have been integrated into regular schools. A contact teacher is posted in every school who works closely with our coordinating office.

The programme also deals with the mobilization of the community for educating the visually impaired children through Community Based organisations. Additional information: Kilimani primary School also houses the Deaf blind unit run by the Ministry of Education to give quality programmes to the youth/ children who are Deaf blind

It is located in the heart of Maasai land. The centre was established to meet the special education needs of these physically impaired children in this district and its environs. A disproportionate number of Maasai children are born with physical impairment. As yet, the reason is unknown.

The Maasai are traditionally herdsmen and as such are transitory, migrating over great distances according to the grazing needs of their cattle. They have no permanent homes and their children migrate too. They are 'neither' farmers, tradesmen nor businessmen. This situation, coupled with low literacy levels, called for the establishment of Tania to take care of orphans, and vulnerable children in this community.
