

## CBR AFRICA NETWORK

#### A REPORT FROM THE CBR AFRICA NETWORK (CAN) INTERNATIONAL ADVISORY BOARD SELECTION PROCESS 2025

## Introduction

On the 9-12th September 2024, CBR Africa network held the 7th CBR/CBID Africa conference that took place at the Imperial resort beach hotel Entebbe, Uganda. During which the General Assembly was conducted on the 11<sup>th</sup> and  $12^{\text{th}}/9/2024$  where members agreed to have five regional representatives for the International Advisory Board from the five regions of Africa who will join another four members to form the International Advisory Board of CAN. This is one of the changes to the constitution. This followed a recruitment process in order to fill up the five positions. This report covers the details of the recruitment process including the objective of the recruitment process, call for selection process, confirmation of applications, the regional representatives and conclusion as follows;

### **Objective of the process**


The overall objective of the recruitment process was to fill up the five positions on the CAN International Advisory Board.

#### Call for applications

The process started with developing an application form which was later sent out on  $4^{\text{th}}/12/2024$  using the digital platforms of CAN including MailChimp, X handle, Facebook, website and on all the WhatsApp platforms where applicants were encouraged to first register as CAN members for them to apply and in that regard a link to register as a CAN member was shared.

Applicants had to fill in the application form in addition to attaching a onepage maximum `motivation letter and a one-page maximum letter of support from their respective organizations and submit to CAN secretariat at <u>info@afri-can.org</u> with copies to the CAN chairperson on <u>dibassiwena.adjayi@gmail.com</u> not later than 17/January/2025.


The call for applications attracted a total of 40 applicants including; 38 from the five regions of Africa and two from outside Africa. Among the ones from Africa included; 17 from East Africa, 2 from North Africa, 7 from West Africa, 4 from Central Africa and 8 from Southern Africa.



## Figure 1: Percentage of applicants per region

The figure above shows that majority of the applicants came from the East African region (45%) followed by Southern Africa (21%), West Africa (18%), Central Africa (11%) and lastly North Africa (5%)

The applicants from Africa included 27 male and 11 females from 21 countries including; Tchad, Cameroon, Kenya, Niger, Nigeria, Botswana, Uganda, Mauritius, Tanzania, Malawi, South Sudan, South Africa, Zimbabwe, Zambia, Namibia, Egypt, Ethiopia, Sierra Leone, Ghana, Togo and Democratic Republic of Congo.

The graph shows that majority of the applicants were males (27) as compared to the females (11).

## **Selection process**

The secretariat identified the selection panel with reference to the constitution which highlights that the panel should consist of the following;

- One representative of the founder members of CAN
- One existing CAN Board member
- One previous CAN chairperson
- One representative from the Umbrella OPD in Africa
- One CAN current donor representative

In that regard the identified members of the panel included;

Once the panel was constituted, a meeting was held to deliberate on how the process was to unfold. A marking template was designed to guide the entire process. Unfortunately, Dr Nganwa had to withdraw from the selection panel so the panel continued with the remaining four members. It was agreed that the panel form teams who will be responsible for reviewing applications from the selected regions. This included individual reviews, peers review where peers had to meet to conclude on the best candidate and the general conclusions where all the selection panel members met to conclude on the successful applicants.

It should be noted that; after the meeting between the two peers for the selected regions, the marking templates were submitted to the secretariat to confirm if all the applicants have been reviewed. In that regard, two members reviewed applications from East and West Africa whereas the Central, North and Sothern Africa regions were reviewed by the remaining two members on the panel. Panel members did not review applications from their own region in the initial rounds.

Candidates were selected based on their applications and suitability considering representation by disability status, gender, and age with priority given to a youth (18-35 years) with a disability and expertise in social media.

A meeting for the selection panel to deliberate on the selection process and confirm the successful applicant from each region was held on 31/01/2025.

# Confirmation of the regional representatives

The panel agreed that the following are the successful candidates from the five regions;
